This document sets forth the official rules ("Official Rules") of the America's Best Racing Fan Choice Awards (the "Sweepstakes"). TERM: Registration for the Sweepstakes opens at 9:01 a.m. Eastern Time (ET) on November 6, 2019 and closes at 4:01:59 p.m. (ET)("Drawing Deadline") on November 20, 2019 (the "Term").

ELIGIBILITY: The Sweepstakes is open to individuals who are 21 years of age and older and a legal residents of the United States (including the District of Columbia). Be sure to follow the instructions on the Webpage on how to vote, provide all required information and submit your entry according to the directions on the screen before the Drawing Deadline. In order to submit a valid entry, each entrant must provide a valid email address and make a selection for a Fan Choice Award winner. LIMIT: ONE (1) ENTRY VIA THE WEBSITE PER EMAIL ADDRESS. Subsequent entries utilizing the same email address will be disqualified. All entries become the property of Sponsors.

Based upon Sponsors' time clock, your Sweepstakes entry will be determined by Sponsors to have been/not been received by the Drawing Deadline. Electronic entries received after the Drawing Deadline will be void. Sponsors are not responsible for lost, late, misdirected, mutilated, incomplete, or illegible entries, or

for any computer-related, online, telephonic, or technical malfunctions that may occur. Entries are void if they are in whole or in part illegible, incomplete, damaged, irregular, altered, counterfeit, produced in error, forged, mechanically reproduced, or obtained through fraud or theft. By entering, you agree to be bound by these Official Rules.

In the event of a dispute regarding who submitted an entry, the entry will be deemed submitted by the Authorized Account Holder of the email address submitted at the time of entry. Sponsors may substitute the prize or any component thereof for another prize (or component, as the case may be) of equal or greater value. All federal, state, and local taxes, fees, and surcharges on prizes are the sole responsibility of winner. ## PRIZE-WAGER:

The wager prize will be provided to the Winner in the form of a voucher that may only be used by the Winner to place a single "win" bet on the outcome of the Breeders' Cup Classic race on November 7, 2020. The Winner has not won Ten Thousand Dollars (\$10,000) but has simply won the right to direct one (1) free "win" wager in the amount of Ten Thousand Dollars (\$10,000) which will be placed on one (1) horse selected by Winner. The wager voucher itself has no cash value to Winner and cannot be transferred or redeemed for cash by the Winner. If the 2020 Breeders' Cup Classic is cancelled for any reason, the \$10,000 voucher will not be awarded and the remaining elements of the Prize shall constitute full satisfaction of Sponsor's prize obligation to winner and no additional compensation will be awarded.
