  - Winner and guest will get to watch a race with influencer Joey Mulinaro. The race will be of Joey Mulinaro's choosing. Approximate Retail Value: \$0.00

# PRIZE-WAGER:

The wagering prizes will be provided to the Winner in the form of two vouchers. The first voucher may only be used by the Winner to place a single "win" bet of five hundred dollars (\$500.00) on the outcome of the Indiana Derby race on July 9, 2022.

The Winner has not won five hundred dollars (\$500.00) but has simply won the right to place one (1) free "win" wager in the amount of five hundred dollars (\$500) which must be placed on one (1) horse selected by Winner prior to such race. The wager voucher itself has no cash value and cannot be transferred or redeemed for cash by the Winner.
